
## **Program Information**

Can I study part-time?	International Students - No. The international student visa does not allow you to study part-time

What careers will I be prepared for?	Cyber Security experts work across both the public and private sectors in all kinds of industries and sizes of organisations. For some examples of possible careers, please the table below		
Can I start out with a Graduate Certificate and then apply for the Master of Cyber Security?	Yes, although articulation into the Master Program is not automatic. You will still need to meet the GPA entry requirements for the program you wish to articulate into.		
Are there early exit options if I decide not to complete the Master Program?	Yes, it is possible to exit with either a Graduate Certificate or Graduate Diploma if you have met the requirements for these programs.		
Are there pre-requisites? Is there any assumed knowledge?	Depending on the program and field of study you choose, there may be enrolment pre-requisites and assumed knowledge. There is no assumed knowledge for the Graduate Certificate in Cyber Security. 	<ul> <li>Graduate Certificate in Cyber Security - no background knowledge is required</li> </ul>
	<ul> <li>Graduate Diploma in Cyber Security - you must have a background in a related area to your chosen field of study</li> </ul>
	<ul> <li>Master of Cyber Security 24 units - you must have a background in a related area to your chosen field of study</li> </ul>
	<ul> <li>Master of Cyber Security 32 units - you do not require a background in your chosen field of study. The additional semester of study (8 units) included in this program will provide the foundational material you need to prepare for the advanced, deep-discipline courses</li> </ul>

Do I need to have a technical background? Do I need to know how to program?	Not always:
	<ul> <li>Cyber Defence - if you have no computer science background you can apply for the #32 unit program</li> </ul>
	<ul> <li>Cyber Criminology - no computer science/ programming background required</li> </ul>
	<ul> <li>Leadership - no computer science / programming background is required</li> </ul>
	<ul> <li>Crytptography - if you have no computer science background you can apply for the #32 unit program</li> </ul>
Can I change my field of study after I have enrolled?	This may be possible. As eligibility requirements and pre-requisites differ for each field of study, a program change application must be made to the EAIT faculty in order to change your field after you have been admitted. We recommend that you seek academic advice before requesting a change.
Can I get credit for similar courses that I took in my undergraduate degree?	You cannot get program credit for courses previously studied. However, depending on the courses that you have taken, you may be eligible to apply for exemption from a similar course in the program. You will be required to take a replacement course / courses with the equivalent number of units, prescribed by the program director and will need to apply for permission to do so.
Are Commonwealth Supported Places (CSPs) available for domestic students?	The UQ Master of Cyber Security Program has been allocated a limited number of CSPs and these will be offered to domestic students on a merit basis after the program application closing date.
Are your programs accredited?	We are working towards provisional accrediation of our new Cyber Security Programs with the Australian Computer Society. Our programs have been designed to align with the USA's National Institute of Standards and Technology's Cyber Security Education (NICE) framework.
